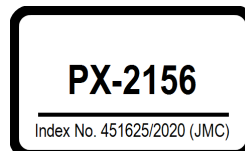

RE: Ethics Complaint for Mr. John Frazer

I am formally filing an ethics complaint against Mr. John Frazer who refused to send a copy of the Directors and Officers Insurance declaration page as requested on multiple occasions.

Timeline of requests:

August 9, 2021 – Email requesting a copy of the D&O policy.  
August 11, 2021 – Email requesting a copy of the D&O policy.  
August 11, 2021 – Email requesting a copy of the D&O policy.  
August 12, 2021 – Phone call to John Frazer requesting a copy of the D&O policy.  
August 12, 2021 – Email requesting a copy of the D&O policy.  
August 12, 2021 – Certified demand letter mailed regarding the D&O policy.  
August 16, 2021 – Phone conversation with John Frazer requesting a copy of the D&O policy.  
August 17, 2021 – Email requesting a copy of the D&O policy.

I discussed the D&O policy request with Mr. Alex Reid ([areid@bakerlaw.com](mailto:areid@bakerlaw.com)) who is an attorney with BakerHostetler and represents the NRA Board of Directors with regard to New York not for profit law. Mr. Alex Reid agreed with my position and felt confident that he could successfully intervene on my behalf. Unfortunately, Mr. Alex Reid's requests were also denied.

As a Director of the National Rifle Association, I have the right of inspection of the books, records, and all entity information and this right is absolute! In addition to my request, I have received communication from at least five NRA Directors who requested a copy of the D&O policy and were also denied.

Ethics Investigation Request:

I am requesting the initiation of a formal ethics investigation for Mr. John Frazer and NRA Officer(s) who instructed Mr. John Frazer to withhold the D&O policy that I requested.
